WHAT WE ASK OF OUR REPRESENTATIVES:

1. TO SIMPLY PROMOTE ACHA- GO TO OTHER CLUBS AND PRESENT ACHA PROGRAMS AND TRY TO GET THEM TO HOLD ACHA HUNTS AND BENCH SHOWS
2. YOUR AREA SHOULD HAVE AT LEAST THREE OR MORE HUNTS PER YEAR
3. A REPRESENTATIVE CAN QUALIFY DOGS FOR THE ACHA WORLD HUNT FOR A FEE OF \$25.00. ACHA RECIEVES \$15.00, THIS INCLUDES REGISTRATION AND THE REP RECIEVES \$10.00. (THE REP GOES WITH THE OWNER & DOG HUNTING ALONE, THE DOG MUST OPEN ON A TRACK, TRAIL AND TREE A COON) IF THE DOG PERFORMS WHAT IS TO BE EXPECTED FROM THE REP, THEN IT WILL BE QUALIFIED. THE REP WILL FILL OUT THE QUALIFYING FORM AND SIGN IT. THE PARTICIPANT NEEDS TO MAIL IT TO THE ACHA OFFICE,ALONG WITH THE \$15.00 FEE
4. AFTER SERVING TWO YEARS OF BEING A REPRESENTATIVE YOU CAN BE NOMINATED FOR A BOARD OF DIRECTORS POSTION (IF ONE COMES AVAILABLE) BASED ON YOUR PERFORMANCE.
